On Wednesday October 26, 2016, I, Ptl. Augustyn #536, was dispatched to 15204 Ramage Avenue for a report of a missing juvenile. Upon my arrival, I met with Carl Merriweather. Carl is the foster parent of Tyshune Bender. Tyshune has been living with Carl since June of 2016.

Tyshune is 14y/o black male, 6'5", 205 lbs, has short black hair, and brown eyes. He was last seen wearing a blue Nike hoodie, blue sweat pants, white Nike shoes, a burgundy hat, and a blue book bag.

Tyshune attends Maple Heights High School and was recently suspended for threatening another student with a firearm. Merriweather last saw Tyshune the evening of October 25 at approximately 0900 hours. The next morning, Merriweather left in the morning and received a phone call from Tyshune asking if he could eat some food in the fridge. Merriweather arrived home at approximately 1200 hours and Tyshune was not home. Merriweather has a storage room in his residence containing a television and an Xbox that he took from Tyshune for disciplinary reasons. This room was broken into and he believes Tyshune took the items. Merriweather waited until the evening to report the incident due to him believing Tyshune would return home.

Tyshune has a cell phone that works through Wi-Fi (216-504-7629). I contacted the number and left a voicemail advising him to contact the police department. Tyshune does not have a vehicle.

Tyshune has anger issues but he does not take medication for it. He has no body piercings or tattoos.

Merriweather allowed Tyshune's photograph to be posted on the county website. Merriweather did not know his dental information.

Tyshune's grandmother, Alice Killings, lives on Maplepark Drive. I contacted her and she has not heard from Tyshune within the past week.
