Dispatch advised Krystle that she needed to come home and look after the children. Krystle refused and I had to contact her daughter's father, Jovan Goodson, who came to the residence and picked the children up. I also made contact with Lauren Reynolds, the mother of one of the juveniles who came to pick up her daughter. Krystle

Josette (homeowner at 14500 Tabor) was having a verbal argument with her "ex-boyfriend" Michael Barrett. Barrett tried to leave Josette's residence by taking possession of the keys for Josette's secondary vehicle, a Buick LeSabre. Her Kia Sol was in the driveway and blocking the Buick, so Barrett attempted to push the Kia out of the way with the Buick's bumper. When that didn't work, he threatened to drive through the back yard and through the neighbor's fence. Barrett did drive the Buick into the back yard, but did not hit the fence. He then took off on foot through Josette's backyard, hopping fences and going through neighbor's yards. Upon our arrival he was already gone. Josette was advised that Michael still has a warrant in our city for unauthorized use of her vehicle and that if he shows up again, she needs to contact us immediately, and not wait for him to start an argument and leave. Barrett did take the keys for the Buick when he left tonight, so Josette was advised to leave her Kia in the driveway, blocking the Buick so he would be unable to remove her vehicle later in the night.
