Southgate USA Manager Flora Wills was advised by her workers that the BMV space was being taken apart and items removed. She (and Southgate) had no knowledge of any workers coming to remove items from the leased space. When she confronted the workers, one of them started to argue with her about moving out. This male was found to be the husband of the leasee/ business owner. Ms. Wills called for PD assistance to avoid any further arguing and for possible help in stopping removal of items. According to Ms. Wills there are also back rent issues with the BMV space. The workers were removing counters that were in the leased space. Ms. Wills provided a copy of the lease to officers showing them the section on fixture ownership. It appeared to state that counters in the space were property of the lease holder (Southgate.)					

The lease holder, Linda XXXX, arrived on scene while officers were present. She disputed the claim that she didn't own the counters. She stated she was removing her personal property. She denied owing any back rent. I showed her the specific section of the lease containing the fixture clause. She stated she was still going to take the items because she felt they were part of what she bought when she purchased the business. She did state that she did not have them installed but that the counters were installed by the previous tenant from whom she purchased the business. I advised her the lease appeared to state the counters should not be removed and that if she was going to continue removal she should use care not to damage any other parts of the space. She agreed. She stated she would be removing all the items she considered personal items (including the counters) and she would be leaving after that was completed.

I advised Ms. Wills of what I told Ms. XXXXX and that she was going to continue anyway. Ms. Wills was advised this was generally a civil matter. Ms. Wills advised she would speak to her attorney about the lease provisions.

No further police action was needed at this time. (TTH#183)
