On Tuesday, August, 29 2017 at 2055 hrs., I, Ptl. Jividen #537, along with other Maple Heights Units, was dispatched to 21016 Hansen Road for the report of a male, Damien Darden, and his fiancé, Shantell Lawshea, engaged in a heated argument. Officers could hear several loud thumping noises come from the upstairs where Darden was supposed to be located. Mutual aid was requested from Walton Hills K-9 Aro and Sgt. Gervase. Officer's went to the second floor of the home and located a closed door at the end of the hallway. Officer's announced their presence but did not receive a response from Darden. Sgt. Officer Gervase, deployed 15 pepper ball rounds underneath the bedroom door. Darden surrendered to officers. Darden was taken into custody without an issue. Darden was treated by Bedford rescue squad for pepper ball exposure. Darden was transported to the Maple Heights Police Department for his warrants.
