AN ORDINANCE AMENDING SECTION 240.05 OF THE CODIFIED ORDINANCES OF THE CITY OF MAPLE HEIGHTS REQUIRING COUNCIL APPROVAL FOR ALL CITY MONIES EXPENDED FOR THE REFURBISHING OF CITY BUILDINGS AND OFFICES AND FOR THE PURCHASE OF OFFICE FURNITURE, DECORATIONS, AND AMENITIES, REGARDLESS OF THE AMOUNT OF SUCH EXPENSE, AND DECLARING AN EMERGENCY.

WHEREAS, Section 240.05 of the City's Codified Ordinances currently provides that expenses and allocations in excess of Five Thousand Dollars (\$5,000.00) for the refurbishing of City buildings and offices and for the purchase of office furniture, decorations, and amenities, must be approved by Council; and

WHEREAS, Councilwoman Madden has recommended that all expenses and allocations for the refurbishing of City buildings and offices and for the purchase of office furniture, decorations, and amenities, must be approved by Council, regardless of the amount of the expense or allocation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio, that:

<u>Section 1.</u> Section 240.05 of the Codified Ordinances of the City of Maple Heights is hereby amended to read as follows, with deletions struck through and additions underlined:

"240.05 COUNCIL APPROVAL FOR EXPENDITURES OVER \$25,000.00.

- (a) Any City monies expended or allocated excluding regular employee benefits, over twenty-five thousand dollars (\$25,000.00), which have not already been authorized by contract or ordinance, are hereby required to be approved by Council. However, any City monies expended or allocated ever five thousand dollars (\$5,000.00) for the refurbishing of City buildings and offices and for the purchase of office furniture, decorations, and amenities, regardless of the amount of such expense or allocation, are hereby required to be approved by Council".
- Section 2. The Clerk of Council is authorized to forward a certified copy of this Ordinance to the publisher of the Codified Ordinances of the City for immediate inclusion of amended Section 240.05 in the current print and electronic editions of the City's Codified Ordinances.
- Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting on the date indicated below, and that all deliberations of this Council and of any of its Committees that resulted

in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance constitutes an emergency measure necessary for the public peace, safety and general welfare of the City and for the further reason that proper approval for certain expenses of the City are obtained, and provided it receives the affirmative vote of two-thirds (2/3) of the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
