WHEREAS, the Finance Director and Police Chief have reviewed proposals for the replacement of seven (7) copiers and recommend that the City enter into sales order and customer care agreements with Lake Business Products for the lease of seven (7) new Canon copiers for a period of 60 months at a rate of \$799.00 per month, plus a 12 month maintenance contract at rates of \$0.0040 per overage for black and white copies and \$0.0250 for overage of color copies, all as is more fully set forth in the agreements on file in the Finance Department, which are incorporated as if fully rewritten herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio, that:

Section 1. Council authorizes the Mayor to enter into sales order and customer care agreements with Lake Business Products for the lease of seven (7) new Canon copiers for a period of 60 months at a rate of \$799.00 per month, plus a 12 month maintenance contract at rates of \$0.0040 per overage for black and white copies and \$0.0250 for overage of color copies, all as is more fully set forth in the agreements on file in the Finance Department, which are incorporated as if fully rewritten herein.

WHEREAS, on January 8, 2018, the City entered into an agreement with Cuyahoga County to establish and jointly fund the Maple Heights-SBA Small Business Performance Grant Program ("Program"), pursuant to the authorization of **Ordinance No. 2017-112**, enacted November 1, 2017, by which the County would provide funding in an amount not to exceed \$150,000, and through which the City would contribute an additional \$50,000; and

WHEREAS, upon recommendation of the Mayor and Planning and Development Director, Council has determined that the City should provide a forgivable loan through the Program to Maple Heights Hardware ("the Company") in the amount of \$11,250.00 from the City and a matching amount of \$33,750.00 from County-contributed funds, for a total loan amount of \$45,000.00, to allow the Company to purchase inventory and make interior and exterior enhancements at 16460 Broadway Avenue, Maple Heights, Ohio.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio, that:

Section 1. The Mayor and Planning and Development Director are hereby authorized to enter into an agreement to provide a forgivable loan through the Maple Heights-SBA Small Business Performance Grant Program to Maple Heights Hardware ("the Company") in the amount of \$11,250.00 from the City and a matching amount of \$33,750.00 from County-contributed funds, for a total loan amount of \$45,000.00, to allow the Company to purchase inventory and make interior and exterior enhancements at 16460 Broadway Avenue, Maple Heights, Ohio, a copy of which agreement shall be on file in the Office of the Planning and Development Director.
