A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH 14900 BROADWAY AVENUE LLC FOR THE SALE OF THE BUILDING AND PROPERTY LOCATED AT 14900 BROADWAY AVENUE FOR DEVELOPMENT AND REHABILITATION FOR A PURCHASE PRICE OF \$10,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, 14900 Broadway Avenue LLC ("the Developer") has advised the Mayor and Planning and Development Director that it desires to purchase the building and property located at 14900 Broadway Avenue (PPN 784-03-005) (referred to as the "Property"), for development and rehabilitation; and

WHEREAS, the Property is owned by the City through its Land Reutilization Program and the Mayor desires to sell the Property to the Developer, with the Developer required to rehabilitate the existing building and keep it as originally designed; and

WHEREAS, pursuant to R.C. 5722.07, the fair market value of the Property, as determined by the Cuyahoga County Fiscal Officer, and after taking into account the required rehabilitation, is Ten Thousand Dollars and Zero Cents (\$10,000.00).

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio that:

- Section 1. The Mayor is hereby authorized to enter into an Agreement with 14900 Broadway Avenue LLC ("the Developer") to sell the building and property located at 14900 Broadway Avenue (PPN 784-03-005) (referred to as the "Property"), owned by the Maple Heights Land Reutilization Program for development and rehabilitation, at a sales price of Ten Thousand Dollars and Zero Cents (\$10,000.00) with the Developer required to rehabilitate the building in compliance with all City and State of Ohio Building Code Standards.
- Section 2. Pursuant to R.C. 5722.07, the fair market value of the Property, as determined by the Cuyahoga County Fiscal Officer, and after taking into account the required rehabilitation, is Ten Thousand Dollars and Zero Cents (\$10,000.00) per lot. Pursuant to R.C. 5722.08 all of the proceeds from the sale of the Property shall be used to maintain the remaining parcels of real property held by the City in its Land Reutilization Program.
- <u>Section 3.</u> The Mayor, Planning and Development Director and the Law Director are authorized to prepare, sign and file with the County Recorder and Fiscal Officer all documents, and tender any closing fees necessary as the Seller to affect the transfer of the Property from the City to the Developer, 14900 Broadway Avenue LLC.
- Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting on the date indicated below, and that all deliberations of this Council and of any of its Committees that resulted in such

AN ORDINANCE AUTHORIZING THE MAYOR AND FIRE CHIEF TO APPLY FOR, AND IF AWARDED, ACCEPT, WITH MATCHING FUNDS OF 10% OF THE AWARD, A FISCAL YEAR 2022 ASSISTANCE TO FIREFIGHTERS GRANT (AFG) FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) FOR OPERATIONS AND SAFETY EQUIPMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the Federal Emergency Management Agency (FEMA) sponsors a grant known as the Assistance to Firefighters Grant (AFG) and is seeking applications through February 10, 2023 for fiscal year (FY) 2022 grants; and

WHEREAS, the primary goal of the AFG is to meet the firefighting and emergency response needs of fire departments and nonaffiliated emergency medical service organizations and since 2001, AFG has helped firefighters and other first responders to obtain critically needed equipment, protective gear, emergency vehicles, training and other resources needed to protect the public and emergency personnel from fire and related hazards; and

WHEREAS, the Mayor and Fire Chief have recommended that the City apply for a FY 2022 AFG grant for operations and safety equipment and resources in an amount not to exceed Fifty Thousand Dollars and Zero Cents (\$50,000.00) for emergency communications equipment and IDLH gas monitoring equipment, which if awarded the City would be responsible for 10% of the total amount awarded.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio, that:

Section 1. Council hereby authorizes the Mayor and Fire Chief to apply for, and if awarded, accept, a FY 2022 AFG grant for operations and safety equipment and resources in an amount not to exceed Fifty Thousand Dollars and Zero Cents (\$50,000.00) for emergency communications equipment and IDLH gas monitoring equipment, which if awarded the City would be responsible for 10% of the total amount awarded.

<u>Section 2.</u> Council hereby appropriates the sum of Five Thousand Dollars and Zero cents (\$5,000.00) to cover the cost of the City's share of the AFG grant.

WHEREAS, Cuyahoga County, per Resolution No. R2022-0275, awarded \$50,000.00 from the District 8 ARPA Community Grant Fund for the Maple Heights Police Department Locker Room Expansion Project; and

WHEREAS, on November 2, 2022, by Resolution No. 2022-99, Council authorized the Finance Director to accept and deposit funding from the District 8 ARPA Community Grant Fund in the amount of \$50,000.00 into the Local Fiscal Recovery Fund, to be used for the Maple Heights Police Department Locker Room Expansion Project; and

WHEREAS, on December 7, 2022, by Resolution No. 2022-120, Council authorized and directed the City Engineer and Calvin Singleton and Associates to begin the preparation of plans and specifications and to provide advertising for bids for the Maple Heights Police Department Locker Room Expansion Project; and

WHEREAS, on January 27, 2023, the bids for the Detention Center – Phase III Overall Conversion were opened and inspected by the City Engineer and Calvin Singleton and Associates to determine the lowest and best bid.

**NOW, THEREFORE BE IT RESOLVED** by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio that:

<u>Section 1.</u> The Council of the City of Maple Heights hereby authorizes the Mayor to enter into a contract with Caves Road Construction for the Detention Center — Phase III Overall Conversion Project, for a cost not to exceed Ninety-Three Thousand Two Hundred Forty-Five Dollars and Zero Cents (\$93,245.00), as more fully described in the bid record on file in the Office of the Finance Director in the City of Maple Heights.

- <u>Section 2.</u> The Council of the City of Maple Heights hereby authorizes the Finance Director to amend the appropriations as required for the expenditures outlined within this Resolution.
- Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting on the date indicated below, and that all deliberations of this Council and of any of its Committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
