WHEREAS, it is the responsibility of the City of Maple Heights to maintain and operate the roadways in the City for the safety of the community; and

WHEREAS, the Ohio Department of Transportation ("ODOT") invites all local governments and political subdivisions to partner with ODOT for the cooperative purchase of rock salt for 2024; and

WHEREAS, as a member of the State Cooperate Purchasing Program, the City of Maple Heights is eligible to participate in the ODOT program and was a program participant in previous salt contracts presently in effect; and

WHEREAS, in order to participate in this program, the City of Maple Heights must complete and submit the purchasing participation agreement for the purchase of Sodium Chloride (rock salt), attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio, that:

RESOLUTION AUTHORIZING PARTICIPATION IN THE ODOT ROAD SALT CONTRACTS AWARDED IN 2024

WHEREAS, the City of Maple Heights (hereinafter referred to as the "Political Subdivision") hereby submits this written agreement to participate in the Ohio Department of Transportation's (ODOT) annual road salt bid in accordance with Ohio Revised Code 5513.01(B) and hereby agrees to all of the following terms and conditions in its participation of the ODOT road salt contract:

- a. The Political Subdivision hereby agrees to be bound by all terms and conditions established by ODOT in the road salt contract and acknowledges that upon of award of the contract by the Director of ODOT it shall be bound by all such terms and conditions included in the contract; and
- b. The Political Subdivision hereby acknowledges that upon the Director of ODOT's signing of the road salt contract, it shall effectively form a contract between the awarded salt supplier and the Political Subdivision; and
- c. The Political Subdivision agrees to be solely responsible for resolving all claims or disputes arising out of its participation in the ODOT road salt contract and agrees that each party hereto shall be responsible for liability associated with that party's own errors, actions, and failures to act.
- d. The Political Subdivision's electronic order for Sodium Chloride (Road Salt) will be the amount the Political Subdivision agrees to purchase from its awarded salt supplier at the delivered bid price per ton awarded by the Director of ODOT; and
- e. The Political Subdivision hereby agrees to purchase a minimum of 90% of its electronically **submitted** salt quantities from its awarded salt supplier during the contract's effective period; and
- f. The Political Subdivision hereby agrees to place orders with and directly pay the awarded salt supplier on a net 30 basis for all road salt it receives pursuant to ODOT salt contract; and
- g. The Political Subdivision acknowledges that should it wish to rescind this participation agreement it will do so by written, emailed request by no later than Friday, May 3rd, by 5:00 p.m. The written, emailed request to rescind this participation agreement must be received by the ODOT Office of Contract Sales, Purchasing Section email: Contracts.Purchasing@dot.ohio.gov by the deadline. The Department, upon receipt, will respond that it has received the request and that it has effectively removed the Political Subdivision's participation request. Furthermore, it is the sole responsibility of the Political Subdivision to ensure ODOT has received this participation agreement as well as the receipt of any request to rescind this participation agreement. The Department shall not be held responsible or liable for failure to receive a Political Subdivision's participation agreement and/or a Political Subdivision's request to rescind its participation agreement.

WHEREAS, Ohio Revised Code Section 128.06(B) requires that counties with fewer than five (5) townships, a population in excess of seven hundred fifty thousand (750,000), and which contain more than one (1) public safety answering point, maintain a 9-1-1 Program Review Committee comprised of the following five (5) members: 1) Chief Executive Officer of the County; 2) Chief Executive of the county's most populous municipal corporation; 3) Chief Executive of the county's second most populous municipal corporation; 4) Chief Executive Officer of a municipal corporation in the county selected by a majority of the legislative authorities of the county's municipal corporations; and 5) a member of a Board of Township Trustees selected by the majority of Boards of Township Trustees in the County; and

WHEREAS, Cuyahoga County, which maintains a five (5) member 9-1-1 Program Review Committee in accordance with Ohio Revised Code Section 128.06(B), currently has a vacancy in the member position of: Chief Executive Officer of a municipal corporation selected by a majority of the legislative authorities of Cuyahoga County's municipal corporations; and

WHEREAS, the Ohio Revised Code Section 128.06(B)(4) requires that the legislative authority of the municipal corporations in Cuyahoga County pass a resolution selecting a Chief Executive Officer of one of the municipal corporations in Cuyahoga County to serve as a member of Cuyahoga County's 9-1-1 Program Review Committee; and

WHEREAS, the City of Maple Heights, upon application of the City Engineer, was awarded a grant in the amount of Seven Hundred Eighty-One Thousand One Hundred Seventy-Five Dollars and Zero Cents (\$781,175.00) for the Hillgrove Avenue Watermain Replacement Project; and

WHEREAS, on October 6, 2021, by Resolution No. 2021-116, Council authorized the City Engineer to begin the preparation of plans and specifications and to provide advertising for bids for the Hillgrove Avenue Watermain Replacement Project in the City of Maple Heights; and

WHEREAS, the Ohio Public Works Commission (OPWC) is contributing up to Fifty-Three Percent (53%) of the cost, up to a maximum of One Million Four Hundred Thirty-Three Thousand One Hundred Thirteen Dollars and Zero Cents (\$1,433,113.00), for additional work to repair storm and sanitary sewers and resurface various streets including Hansen, Watson, Raymond, Franklin, Hillgrove, Clare and Gardenview; and

WHEREAS, on April 4, 2024 the bids for the Hillgrove Avenue Watermain Replacement Project were opened and inspected by the City Engineer to determine the lowest and best bid.

NOW, THEREFORE BE IT RESOLVED by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio that:

<u>Section 1.</u> The Council of the City of Maple Heights hereby authorizes the Mayor to enter into a contract with Fabrizi Trucking and Paving Company, for the Hillgrove Avenue Watermain Replacement Project, for a cost not to exceed One Million Six Hundred Eighty-Seven Thousand Six Hundred Ninety-Two Dollars and Forty Cents (\$1,687,692.40), as more fully described in the bid record on file in the Office of the Finance Director of the City of Maple Heights.

<u>Section 2.</u> The Council of the City of Maple Heights hereby authorizes the Finance Director to amend the appropriations as required for the expenditures outlined within this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting on the date indicated below, and that all deliberations of this Council and of any of its Committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Resolution constitutes an emergency measure necessary for the public health and welfare and further to ensure the timely completion of this construction project and provided it receives the affirmative vote of two-thirds (2/3) of the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
