WHEREAS, the City of Maple Heights cherishes the value and dignity of each person and appreciates the importance of equality and freedom; and

- **WHEREAS**, all persons are welcome in the City of Maple Heights to live, work, play, and every family, in any shape, deserves a place to call home where they are safe, happy, and supported by friends and neighbors; and
- WHEREAS, the City of Maple Heights denounces prejudice and unfair discrimination based on age, gender identity, gender expression, race, color, religion, marital status, national origin, sexual orientation, or physical attributes as an affront to our fundamental principles; and
- WHEREAS, Pride month began in June of 1969 on the one-year anniversary of the Stonewall Uprising in New York City after LGBTQ+ and allied friends rose up and fought against the constant police harassment and discriminatory laws that have since been declared unconstitutional; and
- WHEREAS, the City of Maple Heights appreciates the cultural, civic, and economic contributions of Lesbian, Gay, Bisexual, Transgender, Queer, plus (LGBTQ+) community which strengthen our social welfare; and
- WHEREAS, it is imperative that young people in our community, regardless of sexual orientation, gender identity, and expression, feel valued, safe, empowered, and supported by their peers and community leaders; and
- WHEREAS, despite being marginalized, LGBTQ+ people continue to celebrate authenticity, acceptance, and love.

WHEREAS, on October 11, 2002, the Cuyahoga County Budget Commission with an affirmative vote of all members waived the requirement for taxing authorities of subdivisions or other taxing units (including schools) to adopt a Tax Budget as provided under O.R.C. Section 5705.281, but instead requires the filing of Alternative Tax Budget Information on an annual basis; and

WHEREAS, the Alternative Tax Budget Information for the City of Maple Heights, Ohio for the fiscal year beginning January 1, 2025 has been prepared and presented to the Council; and

WHEREAS, after due consideration, Council deems it advisable in the interest of the Municipality to adopt the Alternative Tax Budget Information.

- <u>Section 2</u>. The Finance Director is authorized to promptly certify a copy of said Alternative Tax Budget Information and transmit the same along with a copy of this Ordinance to the Budget Commission of Cuyahoga County, Ohio.

WHEREAS, the Maple Heights Service Director has informed the Mayor and the City Engineer that municipal leaf collection and composting can be provided most cost effectively by utilizing Service Department personnel to collect leaves and composting them at the municipally owned property located at 14580 Schreiber Road; and

WHEREAS, the City of Maple Heights is currently operating under the Ohio EPA's National Pollutant Discharge Elimination System (NPDES) Storm Water General Permit Coverage (Small MS4 General Permit) which gives authorization to discharge to the surface waters of Ohio; and

WHEREAS, the Ohio EPA's (NPDES) Storm Water General Permit for a Small MS4 (Municipal Separate Storm Water System) requires the City of Maple Heights to provide effective storm water management by using a holistic system management approach known as Best Management Practices (BMPs); and

WHEREAS, the Ohio EPA's BMPs encourage Pollution Prevention and Good Housekeeping at all municipal facilities including, but not limited to roadways, maintenance areas, storage yards, waste transfer stations and composting facilities; and

WHEREAS, leaves that accumulate on tree lawns and in roadway gutters can cause blockages in catch basins and storm sewers and also release pollutants into MS4s that ultimately discharge to the surface waters of Ohio; and

WHEREAS, the Northeast Ohio Regional Sewer District (NEORSD) provides funding to Member Communities, including the City of Maple Heights, for community specific storm water management projects under the Community Cost-Share Program; and

WHEREAS, the City Engineer and the Service Director have been informed by the NEORSD that the procurement of leaf collection equipment would effectively serve as a Pollution Prevention and Good Housekeeping BMP and thus qualify as a storm water management project eligible for Community Cost-Share Program funds; and

- WHEREAS, the City Engineer and the Service Director have made application to the NEORSD for the disbursement of Community Cost-Share Program funds associated with the procurement of leaf collection equipment in the amount of Fifty-Nine Thousand Dollars and Zero Cents (\$59,000.00) for such activities; and
- WHEREAS, Sourcewell is a service cooperative established by Minn. Stat. § 123A.21 as a local unit of government pursuant to the Minn. Const. art. XII, sec. 3 and is authorized to provide a Cooperative Purchasing Program by Minn. Stat. §123A.21, subd. 7(23) to participating entities; and
- WHEREAS, participation in Sourcewell's Cooperative Purchasing Program is open to eligible participating entities registering with Sourcewell, including: a state, city, county, town, village, school district, or political subdivision of any state of the United States; and
- **WHEREAS**, the City is a member of, and participating entity in, Sourcewell's Cooperative Purchasing Program (Member No. 105385); and
- WHEREAS, Sourcewell's Cooperative Purchasing Program provides purchasing that is "Procurement conducted by, or on behalf of, one or more Public Procurement Units" as defined by the American Bar Association Model Procurement Code for State and Local Governments and Sourcewell's analysts streamline the procurement process by developing requests for proposal (RFPs) and invitations for bids (IFBs) for national, competitive solicitations that meet or exceed local requirements; and
- WHEREAS, Sourcewell, on March 11, 2021, advertised for RFPs (RFP No. 031121) for Grounds Maintenance Equipment, Attachments, and Accessories and on May 2021 (Resolution No. 2021-12) awarded a contract to Old Dominion Brush Company to provide Grounds Maintenance Equipment, Attachments, and Accessories for purchase through Sourcewell's Cooperative Purchasing Program (Contract No. 031121-ODB); and
- WHEREAS, R.C. 9.48(B)(2) and (C) permits the City to participate in a joint purchasing program like Sourcewell's Cooperating Purchase Program and is exempt from Ohio's competitive bidding requirements because Contract No. 031121-ODB was awarded pursuant to a publicly solicited request for a proposal by Sourcewell, a political subdivision of another state; and
- **WHEREAS**, the Mayor and Service Director have advised Council that the City is in need of a new 10 Cubic Yard X-Treme Vac Trailer Mounted Debris Collector for leaf collection, and that it be purchased from Best Equipment pursuant to Sourcewell Contract No. 031121-ODB in the total amount of \$59,000 pursuant to Best Equipment's February 9, 2024 Proposal which is on file in the Service Department; and
- WHEREAS, Council desires to follow the recommendation of the Mayor and Service Director and authorize the purchase of a new 10 Cubic Yard X-Treme Vac Trailer Mounted Debris Collector for leaf collection, and that it be purchased from Best Equipment pursuant to Sourcewell Contract No. 031121-ODB in the total amount of \$59,000.00 pursuant to Best Equipment's February 9, 2024 Proposal which is on file in the Service Department;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio that:

WHEREAS, the Northeast Ohio Public Energy Council ("NOPEC") has established a community grant program for participating NOPEC communities called the NOPEC Energized Community ("NEC") Grant Program; and

WHEREAS, the City of Maple Heights is a NOPEC member and has received a 2024 NEC Grant award for \$43,212.00 to be used for municipal energy efficiency and energy infrastructure projects; and

**WHEREAS**, the City of Maple Heights has been advised by NOPEC that prior year NEC Grant award funds in the amount of \$69,040.15 remain on account to be used for municipal energy efficiency and energy infrastructure projects; and

WHEREAS, the City Engineer sought five (5) price proposals and received three (3) price proposals and determined that D. E. Williams Electric, Inc. had submitted the lowest and best proposal for the Lee-Libby Pocket Park Site Lighting Improvements Project which directly addresses site lighting. Such proposal, including contractor allowance, was in the total amount of Sixty-Two Thousand Dollars and Zero Cents (\$62,000.00); and

WHEREAS, on April 3, 2024, by Resolution No. 2024-33, Council authorized the Mayor to enter into a contract with D. E. Williams Electric, Inc., in an amount not to exceed Sixty-Two Thousand Dollars and Zero Cents (\$62,000.00) for the Lee-Libby Pocket Park Site Lighting Improvements Project; and

WHEREAS, the City Engineer, after consulting with the Chief Building Official, has directed the D. E. Williams Electric, Inc. to upgrade and relocate the proposed electric meter and panel base to provide additional safety, aesthetics and security with such work increasing the contract cost for the Lee-Libby Pocket Park Site Lighting Improvements Project in the amount of Two Thousand Six Hundred Ninety-Six Dollars and Eighty-One Cents (\$2,696.81).

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT TO SELL FIFTEEN (15) VACANT LOTS OWNED BY THE CITY THROUGH ITS LAND REUTILIZATION PROGRAM TO GLH LLC FOR A TOTAL AMOUNT OF \$37,501.00, FOR THE CONSTRUCTION AND SALE OF A SINGLE FAMILY, OWNER-OCCUPIED HOME ON EACH PROPERTY, AND DECLARING AN EMERGENCY.

WHEREAS, GLH LLC ("the Developer") has advised the Mayor and Planning and Development Director that it desires to purchase fifteen (15) vacant lots owned by the City through its Land Reutilization Program and/or Land Bank, which lots are described in Schedule 1 attached hereto and incorporated herein, (each referred to as the "Property", and together as the "Properties") for the construction and sale of a single family, owner-occupied home on each Property; and

WHEREAS, the Properties are owned by the City through its Land Reutilization Program and/or Land Bank and the Mayor desires to enter into a Real Estate Purchase and Development Agreement ("Agreement") with the Developer, a copy of which is on file in the office of the Planning and Development Director, to sell the Properties to the Developer, with the Developer required to build a single family, owner-occupied home on each Property within three (3) years after the effective date of the Agreement ("completion date") and to make the following minimum improvements: 1) the homes must be an owner-occupied single family; and 2) the homes must have at least three (3) bedrooms, two (2) baths, and two off-street parking spaces, one of which must be a totally enclosed attached garage ("the minimum improvements"); and

WHEREAS, pursuant to R.C. 5722.07, the fair market value of the fifteen (15) Properties, as determined by the Cuyahoga County Fiscal Officer, and after taking into account the required minimum improvements; the completion date, and the number of Properties purchased at one-time, is a total amount of Thirty-Seven Thousand Five Hundred One Dollars and Zero Cents (\$37,501.00).

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio that:

Section 1. The Mayor is hereby authorized to enter into the Real Estate Purchase and Development Agreement with the Developer ("Agreement"), a copy of which is on file in the office of the Planning and Development Director, to sell the Properties to the Developer for a total purchase price of Thirty-Seven Thousand Five Hundred One Dollars and Zero Cents (\$37,501.00), with the Developer required to build a single family, owner-occupied home on each Property within three (3) years after the effective date of the Agreement and to make the following minimum improvements: 1) the homes must be an owner-occupied single family; and 2) the homes must have at least three (3) bedrooms, two (2) baths, and two off-street parking spaces, one of which must be a totally enclosed attached garage.

Section 2. Pursuant to R.C. 5722.07, the fair market value of the fifteen (15) Properties, as determined by the Cuyahoga County Fiscal Officer, and after taking into account the required minimum improvements; the completion date, and the number of Properties purchased at one-time, is a total amount of Thirty-Seven Thousand Five Hundred One Dollars and Zero Cents (\$37,501.00).

Pursuant to R.C. 5722.08 all of the proceeds from the sale of the Properties shall be used to maintain the remaining parcels of real property held by the City in its Land Reutilization Program.

<u>Section 3.</u> The Mayor, Planning and Development Director, and the Law Director are authorized to prepare, sign and file with the County Recorder and Fiscal Officer all documents, and tender any closing fees necessary as the Seller to effect the transfer of the Properties from the City to the Developer, GLH, LLC.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting on the date indicated below, and that all deliberations of this Council and of any of its Committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution constitutes an emergency measure necessary for the public peace, safety and general welfare of the City and for the further reason to allow the Developer to timely commence construction, and provided it receives the affirmative vote of two-thirds (2/3) of the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force from and after the earliest period allowed by law.

AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT A MAY 6, 2024 REPAIR WORK ORDER FROM TK ELEVATOR IN THE AMOUNT OF \$63,756.00 TO COMPLETE REPAIRS TO THE SENIOR CENTER ELEVATOR AND TO USE NOPEC GRANT FUNDS TOWARDS THE COST OF THOSE REPAIRS; AND APPROVING TWO PREVIOUS REPAIR WORK ORDERS FROM TK ELEVATOR IN THE TOTAL AMOUNT OF \$108,631.00, WHICH AMOUNT WAS FUNDED BY ARPA FUNDS RECEIVED BY THE CITY FROM THE WESTERN RESERVE AREA AGENCY ON AGING (WRAAA); AND DECLARING AN EMERGENCY.

WHEREAS, the Western Reserve Area Agency On Aging ("WRAAA") received funds from the Ohio Department of Aging ("ODA"), which funding originated from the Federal Government through the American Rescue Plan Act ("ARPA"); and

WHEREAS, through Ordinances Nos. 2023-60 and 2024-10, Council authorized the Mayor, on behalf of the City of Maple Heights, to enter into a contract, and addendum to the contract, with WRAAA for the purpose of providing ARPA Services as described in the American Rescue Plan to persons sixty (60) years of age and older ("Consumers") and to develop and implement a comprehensive and coordinated system of services for Consumers and their caregivers, for which services the WRAAA will pay the City as Contractor with ARPA funds in the maximum amount of One Hundred Eight Thousand Seven Hundred Eighty Dollars and Zero Cents (\$108,780.00); and

WHEREAS, the City requested, and WRAAA agreed, to provide the City with the \$108,780.00 in ARPA funding for repairs to the elevator in the City's Senior Center, which elevator services Consumers; and

WHEREAS, the City accepted from TK Elevator a Repair Work Order dated October 4, 2023 in the amount of \$65,780.00, and a Repair Work Order dated January 10, 2024, in the amount of \$42,851.00, for a total of \$108,631.00 in repairs to be made by TK Elevator, which repairs the City will pay for out of the \$108,780.00 of ARPA funds received through WRAAA; and

WHEREAS, TK Elevator has advised the City that further repairs to the elevator are necessary and has presented the Mayor with a Repair Work Order dated May 6, 2024 in the amount of \$63,756.00; and

WHEREAS, NOPEC has advised the Mayor that funds the City has received though its annual NOPEC Energized Community Grant Program (NEC Grant) could be used to pay for the further repairs necessary to the Senior Center Elevator; and

WHEREAS, the City has available NEC Grant funds in the amount of \$31,878.00 to be used towards TK Elevator's May 6, 2024 Repair Work Order in the amount of \$63,756.00, leaving a balance of \$31,878.00 to be paid out of the City's General Fund.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Maple Heights, County of Cuyahoga, State of Ohio that:

- Section 1. Council hereby approves the TK Elevator Repair Work Order dated October 4, 2023 in the amount of \$65,780.00, and the TK Elevator Repair Work Order dated January 10, 2024, in the amount of \$42,851.00, for a total of \$108,631.00 in repairs to be made by TK Elevator, and authorizes the Finance Director to pay TK Elevator for these Repair Work Orders out of the \$108,780.00 of ARPA funds received through WRAAA.
- Section 2. Council hereby authorizes the Mayor to accept TK Elevator's Repair Work Order dated May 6, 2024 in the amount of \$63,756.00, for further repairs to the Senior Center Elevator and authorizes the Finance Director to use NEC Grant funds in the amount of \$31,878.00 towards TK Elevator's May 6, 2024 Repair Work Order in the amount of \$63,756.00, and directs the Finance Director to pay the balance of \$31,878.00 to be paid out of the City's General Fund.
- Section 3. To the extent not already done, the Finance Director is hereby authorized and directed to appropriate a sum sufficient to cover the cost of the amounts set forth in Sections 1 and 2 above.
- <u>Section 4.</u> It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its Committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- Section 5. This Ordinance is hereby determined to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Maple Heights and for the further reason that timely repairs to the elevator are necessary for the day-day operation of the Senior Center and provided it receives the affirmative vote of two-thirds (2/3) of the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force from the earliest period allowed by law.
