Pay your taxes the easy way...

EasyPay makes paying property taxes simple. Sign up now and your property taxes can be automatically deducted from your checking or savings account. You will still receive a tax bill notifying you of the amount due and withdrawal date, but you will no longer need to write and mail a check or stand in line to pay your taxes.

You can *EasyPay*:

- **Monthly** – half of your estimated tax bill will be withdrawn from your account around the 5th of each month. Each January and July, the adjusted balance due for the tax collection period will be withdrawn on the last day of the collection.
- **Twice a year** – withdrawals may be scheduled for the last day of each collection period. You may also elect to have your first half payment made on the last business day of December.
- **Once a year** – you may choose to have your full year tax amount withdrawn from your account on the last business day of December or on the last day of the collection in January.

Why enroll in *EasyPay*? Because *EasyPay* is:

Convenient – no more writing checks or standing in line. Your scheduled payments will be automatically deducted from your bank account.

Economical – save money, checks and postage. Monthly prepayments with *EasyPay* can earn you a small discount on your taxes.

Secure – your personal banking information is kept strictly confidential.

Assured – your payment is always on time. No more missed payments or late payment penalties.

Budget Smart – smaller monthly payments make budgeting easier.

How to enroll...

- Complete and submit the *EasyPay* prepayment application available on the Treasurer's website: www.treasurer.cuyahogacounty.us.
- A separate application is needed for each property.
- Choose the *EasyPay* option that is best for you: monthly, semi-annual or annual. For annual and semi-annual *EasyPay*, select the withdrawal date for your first half payment (December or January).
- If you select monthly withdrawals, a payment schedule will be sent to you.

Note: Should you wish to discontinue your automatic payments, you must notify the Cuyahoga County Treasury Department, in writing, at least ten days before the next scheduled withdrawal.

Not quite ready for automatic withdrawal?

Monthly tax payments may also be made by check or money order. Sign up for our *EasyPay* coupon program and you will receive coupons and return envelopes to make monthly payments at your convenience.
