## Introduction

#### Overview

The Department of Human Services main responsibilities include directing and supervising the Maple Heights Senior Center, the Maple Heights Food Pantry and Mobile Market, City of Maple Heights sponsored Special Events, Youth and Family Engagement and other programs and services as assigned by the Mayor.

### History

The City of Maple Heights Department of Human Services has provided a high quality of service delivery to the residents of Maple Heights for the past 50 years. It is located in the Maple Heights Senior Center at 15901 Libby Road in Maple Heights, Ohio. We are a multi-purpose agency offering programs and services to individuals, families, older adults and disabled individuals regardless of race, religion, gender, national origin or ethnicity.

## Content

Our department received over 1,400 phone calls or walk ins from people inquiring about financial assistance, food, housing, medical or transportation assistance. We received over \$110,000.00 in grant monies to provide various programs to our community. Beacon Grove Apartment is set to open in early 2024 and will bring an influx of new residents to our city. Our community food pantry and produce market continue to provide ample amount of food to assist in alleviating food insecurity. We continue to offer programs and services to help people meet their essential needs, such as wellness, shelter and financial stability.

Our department remains dedicated to raising the quality of life for our residents whenever possible. 

# Maple Heights Department of Human Services Office on Aging

#### **Congregate Meals**

The Maple Heights Office on Aging Congregate Meals Program provides daily meals Monday through Friday that provide a minimum of 1/3 of the Recommended Dietary Allowances for persons 60+ years of age. Our program endeavors to promote nutritional health, reduce social isolation and link older adults to needed services.

Meal Reservations are taken Monday, Tuesday, and Wednesday of each week for the following week. Reservations can be made by telephone or in person on-site. A donation box is available in the dining room for consumers to contribute towards the congregate meal. We serve 25-50 meals a day allowing us to meet our contracted number with the Western Reserve Area Agency on Aging.

# Maple Heights Department of Human Services Office on Aging

#### Home Delivered Meals

The Maple Heights Office on Aging Home Delivered Meals Program provides daily meals Monday through Friday, that provides 1/3 of the Recommended Dietary Allowances for person(s) 60+ years of age. The purpose of our service is to maintain and/or improve the consumer's health by providing a nutritious meal to one who is unable to prepare his/her own meal, unable to participate in the congregate nutrition program and lacks another manner to procure a meal in the home.

Requests for home delivered meals are referred to the Assistant Director. She determines if the person who wishes to receive meals meets the eligibility criteria for home delivered meals. If the older adult meets the criteria, a plan for receiving the meals and program orientation is initiated. Drivers use a route sheet which includes name, date and number of meals provided to the consumer and signs their name to the sheet after completion of meal delivery. Staff and volunteers deliver 75-80 meals a day, five days a week, allowing us to meet our contracted number of meals with the Western Reserve Area Agency on Aging.

# Maple Heights Department of Human Services Office on Aging

#### Transportation

Seniors 60 years or older or disabled individuals under 60, who reside in the City of Maple Heights can request van transportation. The Maple Heights transportations services can be used for medical and dental appointments, therapy and dialysis appointments, grocery shopping, banking, the Maple Heights Senior Center, other social service agencies, barbers and hairdressers, and special events in the community. Our service is provided Monday through Friday, from 8:30 AM to 3:00 PM. Transportation to special events and city activities is also available on some evenings and weekends.

Our vehicles are dispatched by the Senior Transportation Connection of Cuyahoga County (STC) dispatchers. The employees of the STC are qualified, courteous and efficient. Van reservations can be made at least 72 hours in advance of the trip, up to two (2) weeks in advance, Monday through Friday, from 7:00 AM to 5:00 PM.

We were awarded a new 10 seat passenger transport van which we received in May.



We will continue to follow safety protocol in accordance with the Greater Cleveland Food Bank's guidelines.



Who is eligible for food:

1 shopping day per household every 30 days

Eligibility is based on income and number of people in the household according to State and Federal regulations.

Proof of eligibility:

- Current photo ID (Driver's license or State ID)
- Proof of residency for each adult member of the household 18 or over (utility bill, cell phone bill, lease agreement, rent/mortgage receipt.)

#### NO EXCEPTIONS

 Proof of residency for children under 18 (School report, School ID, Documentation from Job and Family Services)

#### NO EXCEPTIONS

If resources permit, you may receive 6 days of food for each person in your household per month.

You will be allowed to authorize another person to receive food on your behalf, if you are unable to come to the food pantry. This person must have a written note from you with the date, your signature and the name of the person authorized to receive food for you. This person must provide their ID Greater Cleveland Food Bank
